### Dear Residents and Leaseholders,

We are pleased to inform you that Starfish Construction has been appointed to carry out the works at **Claremont Place**. Please find below the latest updates regarding the reinstatement works and onsite activities scheduled for the week ending **Friday 14th November 2025**.

### News & Updates

Dear Residents,

We would like to remind all residents that access to our **construction and welfare areas** is **strictly prohibited**. Recently, a fencing strap in the basement was cut to gain access to the welfare area — this is a serious **Health & Safety breach**. These areas are for site personnel only and contain potential hazards that could cause injury. Please do not attempt to enter or tamper with any of the barriers or fencing in place.

In addition, please be aware that **access to the podium and balconies** is now **restricted** as scaffold erection works are ongoing. These restrictions are being implemented **progressively**, and areas will remain closed until it is safe to reopen them.

We must stress that entering any **scaffold exclusion zone** poses an **extremely high safety risk**. Unfortunately, our scaffolders have already observed **seven attempts** by residents to access these restricted areas, which not only creates a danger to those individuals but also disrupts essential work and safety procedures.

Your cooperation is vital to maintaining a safe environment for everyone on site. Please respect all signage and barriers and allow our team to carry out works safely and efficiently.
